

## Course Program Survey for EOUST

Submit July 1, 2006

The below survey was prepared for the Executive Office for U.S. Trustees (EOUST) as part of our courses approval as a personal financial management instructional debtor education course under the new Bankruptcy Code that went into effect October 17, 2005.

The survey covered the period of January 18, 2006 to June 31, 2006. In that time period the approved TakingControl Debtor Education Program course educated 4,041 individual debtors throughout 46 states for their post-discharge bankruptcy requirement. Of the 4,041 debtors, 2,042 were taught through a 2-hour telephone course and 1,999 were taught through the 2-hour Internet course.
